- The event is an open competition, and will be a navigation trial type event held under the International Sporting Code of the FIA, the General Competition Rules of Motorsport Ireland, Appendices 33, 34 of the Motorsport Ireland yearbook, these supplementary regulations and any final instructions issued before the start of the event.
M.I. Permit No: **16/005**
- The event will be run according to the relevant regulations published in the 2016 Year Book of Motorsport Ireland (which equate to those of the 2015 Year Book as revised by the September Motor Sport Bulletin) and any amendments of the regulations published by MI.
- Route will be approximately 80 miles in length. Petrol will be required for approx. 80 miles without refuelling. Controls, time points and vias will define the route (including the route for Speed Regulation Sections) which must be visited in the order stated. Except for run-out to First Competitive point and the SRS Section, Grid references only will be used to give location and required approach and departure of the required points will also be given (i.e. No Tulips, herringbones or traces will be used for the main section of the event). Additional explanatory diagrams may be given for complicated junction layouts.
- Maps used: OSI Discovery Series, Sheets 79 (3rdEd), 85 (4th or 5th Ed will do).

- Check-in and scrutiny will be from 19.00 hours on Saturday, 16th January 2016 at Macroom Golf Club (335½726 - Entry thru Castle Gate Arch in Town Square) (NB - Respect 1-way system in Square on Approach to Gate. Parking restrictions will be in place at the venue, and competitors and any vehicle associated with a competitor must park as directed, In addition, particular care must be taken to avoid excessive noise in the Town Centre. The Stewards will be asked to approve a 10 penalty for non-compliance with these parking & noise requirements as per 21.24 of App 33.

7. Any crew who have not satisfactorily completed Check-in paperwork by 20.30 and/or have not passed Mechanical Scrutiny by 21.00, on Saturday 16th January will not be allowed start the event. Where prior notification of a difficulty with this requirement is given, and at the sole discretion of the organisers, this rule may be relaxed. Preliminary route card & Time Cards will be issued at 20.15, seeding at 21.10. Main Route Card will be issued not later than 21.30 but in the case of up to 6 points the locations and required route may be issued to competitors at a later time. **First Competing Car starts at 23.01.**
