2. The event is an open competition, and will be a navigation trial type event held under the International Sporting Code of the FIA, the General Competition Rules of Motorsport Ireland, Appendix 33 and 34 of the Motorsport Ireland yearbook, these supplementary regulations and any final instructions issued before the start of the event.

M.I. Permit No: 13/180

3. The event will be run according to the relevant regulations published in the 2013 Year Book of Motorsport Ireland and any amendments of the regulations published by MI.

4. Route will be approximately 85 miles in length. Controls, time points and vias will define the route (including the route for Speed Regulation Sections) which must be visited in the order stated. Grid references will be used to give location of the various points, and the required approach and departure will also be given. Other forms of navigation may also be used. Out of bounds/Non-goers will be handed out from 20.30, before route instructions are issued. Additional explanatory diagrams may be given for complicated junction layouts. The entire of the route will be issued prior to the start, save that details of up to 6 locations may be issued to competitors at a later time.

5. Maps to be used: OSI Discovery Series, Sheet No. 86 (3<sup>rd</sup> Ed). Romer used – Eric Hopkirk.

6. Check-in at HQ will be from 19.30 hours on Saturday, 2<sup>nd</sup> November 2013 at Crookstown Community Centre (429.5 657). Any crew who have not satisfactorily completed Check-in paperwork by 20.30 hours and/or have not passed Mechanical Scrutiny by 21.30 hours, on mmmmmSaturday 2<sup>nd</sup> November will not be allowed start the event. Where prior notification of a difficulty in complying with this requirement is given, and at the sole discretion of the organisers, this rule may be relaxed. Trailer park and unloading area will be located in Cronin's Commercial Park (426.5 660). All trailers to be parked here and all cars to be unloaded here. Scrutiny will take place in Martin Sheehan's Garage (429.5 658). **ABSOLUTELY NO TRAILERS/UNLOADING AT HQ.** Parking at HQ is reserved for officials, marshals and competing cars only. Out of Bounds/Non-goers will be issued @ 20.30, Route Instructions will be issued @ 22.45. Drivers briefing will take place @ 23.15 approx. First Competitive Cars starts @ 00.00 (at Crookstown Community Centre).

8. **Classes:** Expert, Semi-Expert, Novice, Beginner as per M.I. Regulations.

Entry fee of €70 excludes Competitors Personal Accident Insurance and IRDS (€120 including competitor's personal accident insurance and IRDS at 2013 standard rate). Drivers/Navigators aged 16 or 17 will pay a reduced C.P.A. rate of €8 each. All competitors must have a valid **2013** Competition Licence and all drivers a **2013** IRDS letter of acceptance. Maximum number of starters is 50. Only paid-up entries accepted.
