2. The event is a open competition, and will be a navigation trial type rally held under the all applicable sections of the International Sporting Code of the FIA, the General Competition Rules of Motorsport Ireland, these supplementary regulations and any final instructions issued before the start of the event.

M.I. Permit No: 08/201

3. Save as modified herein, the event will be run according to the relevant regulations published in the 2008 Year Book of Motorsport Ireland (Appendix 33 & 34), including any amendments of the regulations published by MI.
4. Route will be approximately 85 miles in length. Petrol will be required for the entire route. Controls, time points and vias will define the route (Tulip diagrams for Speed Regulation Sections) which must be visited in the order stated. Grid references only will be used to give location of the various points, and the required approach and departure will also be given. Additional explanatory diagrams may be given for complicated junction layouts. The entire of the route will be issued prior to the start, save that details of up to 6 locations which may be issued during the course of the event.
5. Maps to be used: OSI Discovery Series, Sheet Nos. 73 (2<sup>nd</sup> Ed),. Romer used – Eric Hopkirk. Competitors are advised that a second copy of Sheet 73 may be advantageous.

6. Check-in and scrutiny will be from 20.00 hours on Saturday 1st 2008 at Buttevant G.A.A. Community Centre. (541094.5). Any crew who have not satisfactorily completed Check-in paperwork by 22.00 hours and/or have not passed Mechanical Scrutiny by 22.45 hours, on Saturday 1st November will not be allowed start the event. Where prior notification of a difficulty in complying with this requirement is given, and at the sole discretion of the organisers, this rule may be relaxed. Competitive Navigation will not begin before 0000 hours on Saturday 1<sup>st</sup> November.

**7. Awards:**

1<sup>st</sup> overall, (2 Trophies)

1<sup>st</sup>, 2<sup>nd</sup>, and, 3<sup>rd</sup> in class (2 Trophies)

8. **Classes:** Expert, Semi – Expert, Novice as per M.I. Yearbook, plus Beginners, being any navigator who would not have competed before 1/9/06. For the purposes of National Championship points, Beginners will be considered as Novices.

9. **Entries:** Entries close on Wednesday 29<sup>th</sup> October, 2008. Entry fee €70 excludes competitors personal accident insurance and IRDS (€120 including competitors personal accident insurance and IRDS at 2008 standard rate). All competitors must have a valid **2008** Competition Licence and all drivers a **2008** IRDS letter of acceptance. Maximum number of starters is 50. No Late entries, only paid-up entries accepted.
